However, any Funeral Arrangements you select will include a charge for our basic services and overhead. This list does not include prices for certain items that you may ask us to buy for you from others on your behalf. These items will be listed as **CASH ADVANCES** on your funeral contract and are defined as any item purchased on your behalf from anyone other than **FEATHERINGILL MORTUARY**. We have no control over these prices, and the charge to you will be the **EXACT** charges of the other company, unless otherwise stated. If legal or other requirements mean you must buy any items you did not specifically ask for, we will explain the reason in writing on the statement we provide describing the funeral goods and services you selected.

“Prior to drafting any contract for goods or services, the responsible party or the decedent’s survivor who is handling the funeral arrangements is entitled to receive a copy of any preneed agreement in the possession of the funeral establishment that has been signed and paid for, in full or in part, by or on behalf of the decedent.”

ITEMIZED CHARGES

MINIMUM SERVICES OF FUNERAL DIRECTOR AND STAFF.....\$1040.00

This is a basic fee we charge every family for our professional services in assisting them with their preferences. It includes a proportionate share of the taxes, licenses, utilities, insurance, workers compensation, health insurance and other business expenses required to serve the public on a 24-hour, ready-to-serve basis. Our charge includes, but is not limited to, consultation with the family, administrative and clerical service, preparation of death certificate for certification by the physician or coroner and necessary permits, filing the death certificate with the appropriate government agencies, consultation with clergy, crematory or common carrier, assistance with union or insurance papers, planning the funeral or memorial service as determined by the family. (This fee is already included in our charges for our PACKAGE PRICING as shown on page 4 for Traditional Service, Direct Cremation, Immediate Burial, and Forwarding Remains to another Mortuary.)

TRANSFER OF REMAINS TO FUNERAL HOME WITHIN SAN DIEGO COUNTY.....\$255.00

Additional Charge for removal of remains from residence.....\$65.00
(Outside San Diego County, add \$2.50 per mile one way)

Transfer of remains to Los Angeles.....\$300.00
Transfer of remains to Riverside.....\$225.00

EMBALMING.....\$280.00

Except in certain special cases, embalming is NOT REQUIRED BY LAW. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing, if you wish shipment of the remains by common carrier (airlines, etc.), or if you require that the remains be held more than 48 hours prior to cremation or interment, etc. IF YOU DO NOT WANT EMBALMING, you have the right to choose an arrangement that does not require you to pay for embalming, such as Direct Cremation or Immediate Burial...(however, if the body is to be held for any reason without Embalming, the law requires refrigeration) our fee per day for refrigeration.....\$50.00

TRADITIONAL FUNERAL SERVICE.....\$2995.00
Includes: Basic service charge, removal from place of death*, embalming, dressing, cosmetology and casketing, general use of facilities and equipment as required for (one) visitation in our chapel of 4 hours or any part thereof, and funeral service in our chapel or church or lodge of your choice, personnel for continuing care and direction of funeral service, including graveside committal service. Also supplied are a memorial book, memorial folders or prayer cards, acknowledgment cards, flower car and driver, and a funeral coach and driver (Limousines, Escorts, Weekend Services, and offsite viewings are an extra charge according to the choice of the family).

DIRECT BURIAL.....\$1695.00
Includes: Basic service charge, removal from place of death*, casketing, direction of graveside committal service, and transportation to cemetery.

DIRECT CREMATION.....\$995.00
Includes: Basic service charge, removal from place of death*, alternative container, transportation to and from crematory, and cremation charge. (Remains are returned in temporary plastic urn).

If you want to arrange a direct cremation, you can use an alternative container. Alternative containers encase the body and can be made of materials like fiberboard or composition materials (with or without an outside covering). The containers we provide are constructed of cardboard.
